Such reviews will be made at a time convenient to the applicant, with advanced notice given to the applicant. Misrepresentation of installation location or measure eligibility may result in forfeiture of the incentive award.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice.
- One rebate check will be issued to the customer applying for each approved and completed application. Where applicable, a separate check will be issued to the contractor for each approved and completed application.
